This is in continuation to Notification No. PMEX/MKT, BD&CSS/2019/29 dated June 12, 2019.

All brokers are hereby informed that National Clearing Company of Pakistan Limited (NCCPL) has extended the KYC Information System (KIS) implementation date till July 5, 2019 for PMEX brokers. Thereafter, registration of all new clients by PMEX brokers will only be possible under CKO regime.

PMEX brokers are advised to immediately initiate Authorized Intermediary (AI) registration process with NCCPL to avoid any inconvenience. The AI registration form is specified in Annexure A.
