Subject: Gazette of Pakistan S.R.O. 1162 (I)/2016


Enclosed, please find for appropriate action, a copy of the Gazette of Pakistan Statutory Notification S.R.O. 1162 (I)/2016, dated 24 September 2016 concerning Libya. The annexed order includes **amendment changes made to the listed entity** in the Libya Sanctions Committee List. Restrictions with respect to assets freeze, travel ban and arms embargo *shall remain intact*. The latest S.R.O. updates our previous Gazette Notifications **S.R.O. 616 (I)/2016 dated 09 June 2016** and covers the changes made to the Libya Sanctions Lists of the United Nations Security Council.

2. In pursuance of the UN Security Council Resolution No. (1970) 2011 and its subsequent resolutions, SROs are issued by the Government of Pakistan whenever the Consolidated List maintained by the 1970 Sanctions Committee is updated.

3. The Consolidated United Nations Security Council List is also updated following all changes made to the Libya Sanctions List. An updated version of the Consolidate List is accessible via the following URL:

ORDER

S.R.O. ¹¹⁶²(1)/2016- WHEREAS the United Nations Security Council vide its Resolutions nos. (1970) 2011, (1973) 2011, (2009) 2011, (2016) 2011, (2017) 2011, (2040) 2012, (2095) 2013, (2144) 2014, (2146) 2014, (2174) 2014, (2213) 2015, (2214) 2015 and (2278) 2016, have imposed arms embargo on Libyan Arab Jamahiriya and travel restrictions and to freeze the funds and other financial resources of certain individuals and entities under Chapter VII of the United Nations Charter;

AND WHEREAS the United Nations (Security Council) Act, 1948 (XIV of 1948) enjoins upon the Federal Government to apply certain measures for giving effect to the decisions of the United Nations Security Council;

NOW, THEREFORE, in exercise of the powers conferred by Section 2 of the United Nations (Security Council) Act, 1948 (XIV of 1948), the Federal Government is pleased to order that the individuals and entities listed in the Annexure to this order *reflecting the updates* made by the Libya Sanctions Committee of the United Nations Security Council in addition to the earlier notifications, shall stand subjected to the travel restrictions and assets freeze in accordance with the aforesaid Resolutions with immediate effect.


