# Subject: Gazette of Pakistan S.R.O. 370 (I)/2018

Enclosed, please find for appropriate action, a copy of the Gazette of Pakistan Statutory Notification S.R.O. No. 370 (I)/2018 dated 15 March 2018 concerning UN Sudan Sanctions regime.

- 2. In pursuance of the United Nations Security Council resolution no. 1591 (2005) and other relevant resolutions concerning Sudan, S.R.O.s are issued by the Government of Pakistan under the UN Security Council Act, 1948, whenever the Sudan Sanctions Committee list is updated/changed in order to provide legal coverage to domestic implementation of certain sanctions measures.
- 3. Vide its resolutions nos. 1556 (2004), 1591 (2005), 1651 (2005), 1665 (2006), 1672 (2006), 1679 (2006), 1713 (2006), 1779 (2007), 1841 (2008), 1891 (2009), 1945 (2010), 1982 (2011), 2035 (2012), 2091 (2013), 2138 (2014), 2200 (2015), 2265 (2016) and 2340 (2017), the UN Security has obliged all Member states to take the following sanctions measures against actors operating in Darfur, and designated individuals and entities under Chapter VII of the UN Charter:

## a) Arms Embargo:

to prevent the supply of arms and related materiel of all types and also of technical training and assistance in relation to actors operating in Darfur;

## b) Travel Ban:

to prevent the entry into or transit through their territories of individuals designated by the Committee for inclusion on its consolidated travel ban and assets freeze list on the basis of the criteria set out in paragraph 3 (c) of resolution 1591 (2005); and

# c) Assets Freeze:

to freeze all funds, other financial assets and economic resources owned or controlled by individuals and entities designated by the Committee.

## **ORDER**

S.R.O. No. 370 (I)/2018– WHEREAS the United Nations Security Council vide its resolutions nos. 1556 (2004), 1591 (2005) ,1651 (2005), 1665 (2006), 1672 (2006), 1679 (2006), 1713 (2006), 1779 (2007), 1841 (2008), 1891 (2009), 1945 (2010), 1982 (2011), 2035 (2012), 2091 (2013), 2138 (2014), 2200 (2015), 2265 (2016) and 2340 (2017) concerning Sudan have imposed certain sanctions measures against actors operating in Darfur, and certain individuals and entities under Chapter VII of the United Nations Charter;

AND WHEREAS the United Nations (Security Council) Act, 1948 (XIV of 1948) enjoins upon the Federal Government to apply certain measures for giving effect to the decisions of the United Nations Security Council;

NOW, THEREFORE, in exercise of the powers conferred by Section 2 of the United Nations (Security Council) Act, 1948 (XIV of 1948), the Federal Government is pleased to order that the individual listed in the Annexure to this order reflecting amendments made by the Sudan Sanctions Committee of the United Nations Security Council shall stand subjected to assets freeze and travel ban in accordance with the aforesaid UNSC resolutions with immediate effect.
